I GIVE DEVISE AND BEQUEATH all my real and personal property of whatsoever kind and wheresoever situate which I shall be possessed of or entitled to or over which I shall have any disposing power at the time of my death (including the proceeds of any policy or policies of insurance on my life) UNTO my daughter SYLVIE MAIMA JARLOV of the City of Wellington Spinster absolutely

AND I APPOINT my said daughter SYLVIE MAIMA JARLOV sole executrix and Trustee of this my will

IN WITNESS whereof I have to this my last will set my hand this *16th* day of *February* One thousand nine hundred and thirty five (1935).

oath and say as follows:

1. THAT I knew Holger Christian Jarlov (also known as Oliver  
Jarlov) of the City of Wellington in New Zealand, Timber Yardman,  
now deceased, when alive and that the said Holger Christian  
Jarlov was resident or was domiciled at Wellington within this  
judicial district and that the nearest Registry Office of this  
Court to the place where the said Holger Christian Jarlov resided  
or was domiciled is at Wellington.

2. THAT the said Holger Christian Jarlov died at Wellington on  
or about the 7th day of September 1958 as I am able to depose  
from having been present at his funeral.

3. THAT I believe the partly printed and partly typewritten  
document now produced bearing date the 26th day of February 1956  
to be the last will and testament of the said deceased and that  
I am the executrix therein named.

4. THAT I will faithfully execute the said will by paying the  
debts and legacies of the said deceased so far as the property  
will extend and the law binds and will, whenever ordered so to  
do after grant of probate to me, file in this Court and verify  
by affidavit a true, full and perfect inventory of all the  
estate, effects and credits of the said deceased which shall  
have come into my hands, possession or knowledge and also a  
full, distinct and proper account of my execution of the said  
will which shall set forth the dates and particulars of all  
receipts and disbursements and show which of the same are in  
my opinion on account of capital and on account of income  
respectively.

5. THAT according to my knowledge and belief, the estate and  
effects of the said deceased in respect of which probate is  
sought to be obtained are under the value of £3800.
