1810-1815 Called No. 3. The Others Not Named or  
Numbered.

- Nov. 6, 1809—Page 451—Div. of est. of Abraham Tally, dec'd, ordered, notice havnig been served on Holland McTyre, guard. of Elizabeth and Benj. Tally, children of said Abraham, dec'd.
- Jan. 1, 1810—Page 456—Div. of est. of Alex. Blair, dec'd, ordered, at the request of James Gardner, Admr., and distributee in right of his wife Elizabeth Gardner, formerly Elizabeth Blair and Felix, John and Barna McKinne, Admrs. and guardians of Janet Stuart Blair, dau. of said Alex. Blair.
- May 7, 1810—Page 459—Petition of James Oliver and wife to divide the est. of Hodgen Holmes, dec'd.
- Page 461—Jacob Beall, son of Zephemiah Beall, dec'd, now of full age, demands a settlement of his guardian, Hezekiah Beall.
